F. 12-26/2010-SKT-II dated 29.05.2013 forwarding therewith a proposal received from **Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi** to start off-campus centre at Agartala. The proposal was examined by the UGC as per the provisions contained in the UGC (Institutions Deemed to be Universities) Regulations, 2010 and an Expert Committee was constituted by the UGC for the on-spot assessment of the proposed off-campus centre. 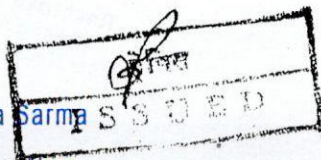
