56-57, Institutional Area, Janakpuri, New Deihi - 110058 NOW, THEREFORE, in recognition of their common interests, and in order to supplement and strengthen the existing understandings for the period of Academic year 2022-23 amongst the two institutions with respect to cooperation and collaboration for the implementation of Certificate in Sanskrit Language (CCSL) and Diploma in Sanskrit Language (DCSL) at the Higher Education Framework in the State of Goa, and Non-Formal Education (NFSE) Central Sanskrit University (CSU) New Delhi confirm their mutual understanding on the following:

## 1. Purpose of MOU

The purpose of this MOU is for Academic Collaboration in order to achieve the goals to promote, develop, propagate, disseminate and preserve Sanskrit Language in all its aspects through any accepted mode including Sanskrit learning under its Non Formal Sanskrit Education (NFSE) activity.

## 2. Scope of Work

The Institutions have agreed to collaborate and partner to achieve the following objectives of this MOU:

- (a) Building and Developing and Holistic Education in Sanskrit;
- (b) Sharing of Human Resources;
- (c) Sharing of Academic and Infrastructural Facilities such as Library, Gymkhana, Classroom, and Staffroom;
- (d) Sharing of other Facilities such as Electricity, House Keeping, Security Services, Canteen and Parking areas;

All these objectives are aimed at achieving greater resource efficiency and desirous of promoting Sanskrit learning to its students / staff and general public within its reach, through NFSE Centre along with other similar academic activities at their organization.

## 3. Role of Government College Khandola (GCASCK)

The Collaborating Institutions have agreed to the following Areas of Collaboration in order to achieve the objectives of this MOU for effective implementation of Sanskrit Language in the State of Goa.

- **3.1** The timetable for Courses/ Programmes shall be set in consultation with GCASCK in a manner that students associated with different programmes can easily register for courses without any timetable clashes for the courses they are attending.
- 3.2 All the Academic and Gym Facilities and other Infrastructure of Collaborating Institutions shall be put to optimum utilization for the overall benefit of students learning Sanskrit Language. Collaborating Institution shall provide access to Library Gymkhana, Classroom and Staffroom for the faculty members and students in the following manner:
- **3.3** The access to Gymkhana facilities shall be provided by GCASCK Institution for promoting Extra Curricular activities as per the rules and regulations of the Institutions.

- 3.4 The access to Classroom and Staffroom shall be provided by GCASCK for the students and faculty members in afternoon time including Sunday's and Holiday's.
- **3.5** GCASCK shall provide all academic facilities, including video-based classes; infrastructure for blended and online learning modes whenever required.
- 3.6 The other facilities such as Electricity, House Keeping, Security Services, Canteen and Parking areas shall be shared by the enrolled students for the Sanskrit Course and faculty members.

# 4. Role of Central Sanskrit University (CSU) New Delhi

- **4.1** NFSE CSU Institution shall allow their faculty members to deliver lectures for Certificate and Diploma Course in Sanskrit Language for the students of the other Institutions that form part as mentioned under this MOU.
- **4.2** The faculty members from parent NFSE CSU engaging lectures for students from partner from GCASCK Institution for a specific course shall carry out all assigned duties, including completion of syllabus, paper-setting, continuous internal evaluation, and final assessment as per the requirements of the Course.
- **4.3** The access to Library and related Text Books in Sanskrit Language shall be provided by parent NFSE CSU.
- 4.4 Certificate in Sanskrit Language (CCSL) and Diploma in Sanskrit Language (DCSL) will be floated for the students and public as an Extension activities of the Collaborating Institutions
- **4.5** the recruitment, appointment, workload, allowances, service rules of the teaching Institutions and the same shall be regulated as per the mandate of the NFSE CSU.
- 4.6 Student Induction Programme (SIP) prior to the commencement of the Academic Year to create awareness among students regarding promotion of the Sanskrit Courses, and infrastructure, various learning pathways, and career opportunities.
- **4.7** The admission, examination, result, and degree shall be awarded by the NFSE CSU in accordance with the Central Sanskrit University, New Delhi.

# 5. Name and Addresses of focal points of the Parties

#### 6. Financial Clauses:

Prescribed monthly remuneration to the Sanskrit Teacher shall be paid by CSU. It is the responsibility of NFSE CSU. GCASCK has no any financial implications on Govt of Goa.

#### 7. Amendment of MOU

The MOU may be modified or amended at any point of time by written agreement between the parties.

Any Collaborating Institution may request in writing for a revision, modification, or amendment of all or any part of the MOU, and any revision, modification, or amendment so unanimously agreed by both the Institutions shall be presented in writing and shall form part of this MOU.

#### 8. Dispute Settlement

In the event of a dispute, controversy or claim arising out of or relating to this MOU, or the breach, termination or invalidity thereof the Parties will use their best efforts to settle promptly such depute through direct negotiation. Any dispute that is not settled within sixty (60) days from the date either Party has notified the other Party of the nature of the dispute and of the measures that should be taken rectify it will be resolved through consultation between the Registrar, Central Sanskrit University, Delhi, and the Principal, Govt. College of Art's, Science & Commerce, Khandola, Marcela, Goa or their duly authorized representatives. Each Party will give full and sympathetic consideration to any proposal advanced by the other to settle amicably any matter for which no provision has been made or any controversy as to the interpretation or application of this MOU.

#### 9. Termination of the MOU

The Parties hereto may terminate this MOU at any time by giving a reasonable written notice, of 30 days, to the other Party of its intention not a carry forward the understanding entered into under this MOU. If the MOU is terminated by either party, steps shall be taken to ensure that the termination does not affect any prior obligation, project or activity already in progress.

# 10. Confidentiality:

Any information furnished by the Government College Khandola GCASCK to the NFSE CSU shall be treated as strictly confidential and the same shall not be disclosed by the NFSE CSU.

# 11. Carry forward of MOU:

If the parties hereto desire to carry forward the understanding entered into under this MOU, then the parties shall execute the necessary Agreement in this respect.
