Notification for Financial Assistance for the year 2016-17 under Schemes

Rashtriya Sanskrit Sansthan (Deemed University) set up by Government of India for the propagation and promotion of Sanskrit language invite applications in the prescribed proforma for Financial Assistance for the year 2016-17 under the revised scheme for the development of Sanskrit Education 2007, under the following activities.

- I. Financial Assistance for Sanskrit Teachers:-
 - a) Financial Assistance for Sanskrit teachers to the Traditional Sanskrit Pathshalas/Mahavidyalayas.
 - b) Financial Assistance for Teachers of Modern Subjects in Traditional Sanskrit Pathshalas/ Mahavidyalayas.
 - c) Financial Assistance for Sanskrit Teachers in Secondary/Higher Secondary schools belonging to State Government Schools.
- II. Financial Assistance for Samman Rashi to Eminent Sanskrit Pandits in indigent circumstances.
- III. Financial Assistance to NGOs/Deemed Universities of various Programmes Activities for promotion of Sanskrit.
- IV. Financial Assistance to Publication, Re-print of Rare& Bulk purchase of Sanskrit books.
- V. Financial Assistance for utilization of services of Retired/Eminent literary Sanskrit Scholars (Shastra Chudamani)
- VI. Financial Assistance to Registered Academic Organizations to conduct "Vocational Training Courses" to the students of Traditonal Sanskrit Pathshalas/Institutions.
- VII. Financial Assistance to Universties/Deemed Universities/ CBSE/NCERT/SCERT etc to improve standards of Sanskrit teaching.

Terms and Conditions

- (a) Application for Financial Assistance for Sanskrit Teachers (a), (b) and (c) of above (I):
 - (1) **For Fresh application:-**
If the institute is of Higher Education/ Secondary Education, the application should be recommended by the Secretary(Education) or the officer deputed for the purpose of respective State Govt.
For renewal of application:-
 - (2) If the applicant institution is of Higher education, the application will be accepted/considered only when it is forwarded by the affiliating University. If the applicant institution is of Secondary/Higher Secondary schools, application will be accepted with endorsement by concerned District Magistrate.
- (b) Application for Scheme mentioned at above (II) should be forwarded by respective Collector/Deputy Commissioner or any other officer not below the rank of first class Magistrate deputed for the purpose.
- (c) Application for the Scheme mentioned at above (III) should be forwarded by the Secretary (Education) of respective State Govt.
- (d) All applications should be addressed to Registrar I/c, Rashtriya Sanskrit Sansthan, 56-57, Institutional Area, Janakpuri, New Delhi-110058 in a closed envelope superscribing "FINANCIAL ASSISTANCE UNDER SCHEME FOR 2016-17" sent by speed post/ Registered Post. **The last date for the receipt of filled in application is 15th May, 2016.** The Sansthan shall not be responsible for any postal delay.
- (e) Application received through email, By hand or incomplete will not be entertained.
