 - b) Auditor should mention his membership Number below his signature. He should clearly mention his ACA/FCA status.
- 3. Registration Certificate for the name of Institution issued by Registrar of Societies.
- 4. Affiliation Certificate.
- 5. Appointment letter and Joining Report of the teachers for the year 2019-20 (Aadhar Card, Mobile No. and Account No. of the teachers).
- 6. List of Students for the year 2019-20 (Category Wise).
- 7. In the case of scholarship of students the Marksheets of Concerned students must be attach.

The application form above schemes should be recommended by the Registrar of the affiliating University if the applicant institute is of Higher Education (Graduate & above).
