





In compliance to the decision of GIAC taken in its meeting held on 10.08.2016 vide item no. 22.8 and approved by Finance Committee, Rashtriya Sanskrit Sansthan in its meeting held on 22.02.2017 vide item no. 34.4 (b) and confirmed by the Board of Management, Rashtriya Sanskrit Sansthan in its meeting held on 25.02.2017 vide item no. 57.3, it is notified for all concerned that the existing financial assistance to the registered academic organizations for conducting Vocational Training Course has been revised from 2017-18 as under:-

1. The Course will be conducted for 2 hours per day in duration of 21 days.
2. Rs.1000/- per day will be granted to the institution and restricted to a maximum of Rs.42,000/-
3. Participating students will be given a participation certificate only after completion of the course and allowances shall be paid.
