**Terms and conditions for the Contract/Guest Faculty to be engaged on contract basis**

1. **Period of engagement** : The period of engagement under this offer shall be for a fixed period till the end of academic session 2022-23, in Central Sanskrit University.
2. **Remuneration:** -
  - i. **Assistant Professor** (On Contract): Rs. 57,700/- + HRA  
(For Hard Station Campuses - Jammu, Garli, Devprayag, Sringeri, Agartala - Additional 10% as special DA plus one time train travel in a year to native place plus medical insurance claim upto Rs. 5000/- per annum).
  - ii. **Guest Faculty** (Assistant Professor Grade) Rs. 50,000/- fixed per month. (Minimum of 50 Lectures per month and other duties assigned by the Director). In case of part payment, weekly with minimum of 14 lectures, Rs. 12500/- per week may be paid.  
(These remunerations are subject to modification by the University from time to time).
3. **Medical Fitness Certificate:** Will have to produce a medical fitness certificate from the Registered Medical Practitioner certifying that the candidate is medically fit for rendering his/her services in the University.
4. **Leave:** Entitled for 8 days Casual Leave per year on prorata basis for the said period of engagement and 12 days Duty Leave for Academic purpose and 8 days Special Causal Leave for medical condition per year.
5. This engagement is made purely on temporary and contractual basis for fixed period.
6. Not entitled to any other benefit such as Confirmation, LTC, Medical reimbursement, etc. which is admissible to the regular employees of the University.
