The agenda contains following items for detailed discussion and approval by the members of the IQAC in the meeting to be held on **26-03-2016** at **11AM** in the **Conference Hall** of the **Rashtriya Sanskrit Sansthan (Deemed University), Delhi** under the chairmanship of the Hon'ble Vice Chancellor:

- Item No. 1** - To take note of the completion of five years period of accreditation on 04-07-2017 and to submit LOI to NAAC by 04-05-2017 and for that preparation works of Reaccreditation to be completed by the end of March, 2017.
- Item No. 2** - To prepare SSR as per NAAC manual.
- Item No. 3** - AQARs for at least three years, 2012-13,2013-14 and 2014-15 may be submitted for reaccreditation.
- Item No. 4** - The Coordinator of IQAC is to ensure the speedy preparation of the AQARs of the campuses by May, 2016 and they are to be consolidated and submitted by June, 2016.
- Item No. 5** - Formation of IQAC in all campuses.
- Item No. 6** - To conduct a NAAC Orientation workshop for Principals and Coordinators of IQAC of all campuses.
- Item No. 7** - The Peer Team Report is to be given to all campuses, so that the implementation of the suggested initiatives and improvements can be presented to the team during visit.
- Item No. 8** - Campuses to document the best practices followed and to send the same to Head Quarters office.

Item No. 9 - To conduct academic Audit in all the campuses.

Item No. 10 - To constitute a committee and send it to Madras University to know about the Academic and Administrative audit.

Item No. 11 - To visit IQAC cells of other universities to know about the best practices carried out.

Item No. 12 - Proposal for the IQAC/NAAC Steering committee to visit at least two universities to know regarding the functioning of the IQAC there.

Item No. 13 - Proposal for RSkS to apply the UGC for 12B status.

Item No. 14 - Proposal to implement NCC in the campuses.
