

2.1 The First Party Central Sanskrit University (CSU) is Established on 30th April, 2020 by an act of Parliament as per the Government of India Gazette No. CG-DL-A-17042020-219068 dated 17th April 2020. Earlier Rashtriya Sanskrit Sansthan was established on 15th October 1970 as an autonomous organisation registered under the Societies Registration Act (XXI of 1860) under the control of MHRD which got transformed as Deemed University in 2002.

CSU is a Premier University for promoting Sanskrit studies in India and abroad. It is the biggest Sanskrit University in the world today which is also the only Multi-Campus Sanskrit University. All-round development of all the branches of Sanskrit learning and availability of Sanskrit resources through modern systems are the main objectives of the University. The University is meant for the upliftment of linguistic diversity and cultural plurality while arranging for teaching and research in Sanskrit, Pali and Prakrit in the context of their mutual cultural inter-relationship. It is also committed for the preservation and upliftment of the philosophical and scientific elements in the knowledge systems of these languages and ensuring their availability through the equipment's of information and communication technology while establishing the relationship of these knowledge systems with cultural legacy.

The other objectives of the University are:

- To disseminate and advance knowledge by providing instructional research and expansion facilities to the promotion of Sanskrit Language courses in humanities, social sciences and science in its educational Government;
- To take appropriate measures for promoting innovations in teaching-learning process and interdisciplinary studies and research;
- To educate and train manpower for the overall development;
- To establish the glory of Sanskrit learning in the global context.

- 2.2 The second Party, the Mauritius Sanatan Dharma Temples Federation (MSDTF) Founded in the late 50's', was registered on 2nd February 1960 having its Registration number 348.
 - At that time a small office was located at 1 Justice Street, Port-Louis. Some years later the direction of the MSDTF decided to have their Head Quarters thereat. To achieve their aim, funds were raised from all corners and at that very moment the unstinted support of Messrs: Beejmohunsing Jomadar, Dayanand Basant Rai, Hookoomsing Prayag, Damodar Toolsee, Joynathsing, Ramlakhan amongst others were solicited. Working tirelessly and with dedication the project was realised.

On 18th July 1982 the Head Quarters of the MSDTF was proudly inaugurated by Sir Anerood Jugnauth, GCSK, KCMG, Q.C Prime Minister of Mauritius at that time.

- The day to day business of the Federation was carried out there at till 2015 when the New Head Quarters of the MSDTF was relocated at Le Triangle, Reduit, coupled with the emergence of the Sanatan College.

Purohit Prashikshana Course will be started from the present Academic session by MSDTF, the details of which are follows:

Purohit Prashikshana Course- The main objective of the three months Prashikshan course is to bring uniformity in the Puja, Havan Paddhati and all Samskaras officiated by the Hindu priests in Mauritius. In near future, many more Prashikshan course like this may also be started.

Admission - The three months Purohit Prashikshan Course is open to all Purohits who are registered as Purohits/Acharyas in the Mandirs run by MSDTF. Nevertheless, if any candidate found suitable to attend the course after due exam/interview he may also be attend the above said course.

The syllabus has been prepared by the Visiting Professors from Central Sanskrit University, New Delhi. The syllabus consist of three papers. The detailed syllabus may be viewed in the annexure I.

Period-The time period of the course will be of three months usually conducted from July to Sept.

Assessment/Exam- The participants will be assessed based on the practical and uniten project/assignment given by the visiting professors at the end of the source and the same will be evaluated

Certificate- The completion certificate will be given to the participants based on the minimum attendance in classes and compulsory assignments/practical. The grade will be decided in the basis of overall performance in the course including attendance, good conduct and timely submission of assignments

The certificate to the participants at the successful completion of the course will be assued jointly by Central Sanskrit University with MSDTP as per the MoU.
