MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is entered into on this 8th day of August, 2025,

BY AND BETWEEN:

International Mandir Prabhandhak Council (IMPC), a trust incorporated under the Indian Trusts Act, 1882, having its registered office at 12P1, Tower 7, Takshila Heights, Sector 37C, Gurugram, Haryana (hereinafter referred to as "IMPC"), which expression shall, unless repugnant to the context or meaning thereof, include its successors-in-interest, executors, administrators, legal representatives, affiliates, and permitted assigns;

AND

Central Sanskrit University (CSU), established under Act No. 5 of 2020 passed by the Parliament of India, having its headquarters at 56-57, Institutional Area, Janakpuri, New Delhi (hereinafter referred to as "CSU"), which expression shall, unless repugnant to the context or meaning thereof, include its successors-in-interest, executors, administrators, legal representatives, affiliates, and permitted assigns.

IMPC and CSU may be collectively referred to as the "Parties" and individually as a "Party".

WHEREAS: The First Party is an organization focused on preserving and promoting the spiritual and cultural heritage of Sanātana Dharma through technology, skill development training, and by setting up "Sanskrit Mahavidyalayas Center for Excellence" in partnership with premier institutes.

WHEREAS: The Second Party is a statutory body under the Ministry of Education, Government of India, for the purpose of planning, promotion, and regulation of the Sanskrit education system in the country.

WHEREAS: The Parties desire to collaborate on a project to digitize and promote Sanskrit educational initiatives.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. PURPOSE

The purpose of this Memorandum of Understanding (MoU) is to establish a collaborative framework between the First Party, an organization committed to preserving and promoting the spiritual and cultural heritage of Sanātana Dharma through the use of Technology, Entrepreneurship, Skill Development and Personality Development Training and the establishment of a "Sanskrit Mahavidyalayas Center for Excellence" in partnership with premier institutes; and the Second Party, a statutory body under the Ministry of Education, Government of India, responsible for the planning, promotion, and regulation of the technical education system in the country. This MoU also includes provisions for exclusive candidate certification by the Second Party (CSU) and a mutual placement partnership between both parties to support the professional advancement of trained candidates.

2. RESPONSIBILITIES OF THE FIRST PARTY (IMPC)

- i. **Strategic Oversight and Planning:** IMPC shall be responsible for providing strategic leadership and oversight in the conceptualization, planning, and phased rollout of the Centers of Excellence (CoEs), in active collaboration with the Central Sanskrit University (CSU).
- ii. **Appointment of Project Management Unit (PMU):** IMPC shall at its sole discretion shall appoint a Project Management/Monitoring Unit who shall be obligated to perform obligations as per clause 4 of this Agreement, as of now, IMPC shall be appointing Bhagva Ontech Private Limited as Project Management/Monitoring Unit.
- iii. **Monitoring, Evaluation, and Compliance:** IMPC shall establish robust systems for monitoring project performance, ensuring that all activities are conducted in accordance with the timelines, standards, and outputs defined in this Agreement and its Annexures.
- iv. **Nodal Facilitator:** IMPC shall serve as the nodal facilitator for effective coordination between the participating academic institutions, PMU, and other stakeholders and IMPC shall ensure smooth communication, operational clarity, and timely decision-making to guarantee the effective implementation of each CoE.

3. RESPONSIBILITIES OF THE SECOND PARTY (CSU)

- i. **Institute Scrutiny:** The Second Party shall identify and recommend a list of institutes affiliated with the CSU deemed suitable for the establishment of the



"Sanskrit Mahavidyalayas Center for Excellence" (COE), such assessment may be based on institutional rankings, academic capabilities, and infrastructural readiness and also in aligned with the proposed locations and infrastructure requirements for setting up the COE are detailed in **ANNEXURE- A** of this Agreement.

- ii. **Circular Issuance and Outreach:** The Second Party shall periodically issue official circulars, notifications, or communications on behalf of the First Party, outlining the comprehensive requirements, eligibility criteria, and operational framework for the establishment of the "Sanskrit Mahavidyalayas Center for Excellence" (COE).
- iii. **Facilitation of MoU Execution:** The Second Party shall facilitate, without assuming any operational or financial obligations, the execution of the Memorandum of Understanding (MoU) between the First Party and the selected Partner Institute that has formally expressed interest in establishing the "Sanskrit Mahavidyalayas Center for Excellence" (COE).
- iv. **Performance Monitoring and Evaluation:** In collaboration with the First Party, the Second Party shall support the monitoring and evaluation of the performance of the "Sanskrit Mahavidyalayas Center for Excellence" (COE) based on the milestones and key deliverables outlined in **ANNEXURE B** of this Agreement.
- v. **SPOC Deputation:** The Second Party shall assign a dedicated Single Point of Contact (SPOC) who will serve as the official and continuous liaison for all communications and coordination between the First Party, the Partner Institutes, and other relevant stakeholders.

4. RESPONSIBILITIES OF THE PROJECT IMPLEMENTATION UNIT (PMU)

- i. PMU shall bear full responsibility for the procurement, installation, and operational readiness of all equipment and infrastructure required for the effective functioning of the Center of Excellence (CoE).
- ii. PMU shall provide ongoing handholding and supervisory support to ensure the smooth day-to-day operations of the CoE.
- iii. PMU shall undertake and complete all necessary accreditation processes, affiliations, and statutory registrations required under the norms of relevant national and state regulatory authorities.
- iv. PMU shall be responsible for all branding, marketing, and promotional activities associated with the Center of Excellence.
- v. PMU shall actively facilitate placement support for students trained at the CoE through its established domestic and international network of recruiters, industry partners, and employment platforms.

5. FINANCIAL INVESTMENT

- 5.1 The First Party (IMPC) agrees to commit a financial investment of up to INR 15 Lakhs per Centre of Excellence (CoE) and the Phase 1 Investment, amounting to INR 10 Lakhs, shall



cover all essential operational and pre-establishment activities, including but not limited to

- i. Pre-visit assessment and Documentation.
- ii. CAAF
- iii. Physical inspection
- iv. Payment of monitoring and oversight fees
- v. Accreditation of job roles and associated approvals; and
- vi. Remuneration of one dedicated Center Manager for managing on-ground execution and coordination.
- vii. Remuneration of one trainer for English speaking.
- viii. Setup of an IT-lab with 20 computers. This will be established only in colleges where IT-lab is not available or cannot be commonly used.
- ix. Provided that the cost borne towards upgradation of the Premises for setting up Center for Excellence shall be deducted from the share of the Institute.

5.2 Further phases of investment, including additional funding tranches, corresponding deliverables, and time-bound milestones, shall be governed by the terms set forth in **Annexure A** to this Agreement.

6. TERM AND TERMINATION

This MoU shall be effective from the date of signing and remain in force for five (5) years unless terminated earlier. Either party may terminate it with six (6) months' written notice in case of a material breach, allowing time to cure the breach if possible. Upon termination, both parties shall settle dues and ensure a smooth handover of responsibilities, assets, and intellectual property. Ongoing training and activities under the Center of Excellence (COE) must continue without disruption, with the Second Party supporting the First Party to complete approved or ongoing programs.

7. INTELLECTUAL PROPERTY

All intellectual property, copyright, trade mark in branding material or otherwise shall be sole and exclusive Property of the respective parties and no parties shall use other intellectual property without permission of the other party. The Parties agree to cooperate with each other in securing and protecting the intellectual property of the Partnership.

8. GOVERNING LAW AND JURISDICTION

This MoU shall be governed by and construed in accordance with the laws of India. Any dispute arising out of or in connection with this MoU shall be compulsory referred to Sole Arbitrator mutually appointed by the Parties in accordance with the Indian Arbitration and Conciliation Act, 1996. The seat and place of arbitration shall be Delhi, and the language of arbitration shall be English.

ROLES & REVENUE

First Party: International Mandir Prabhandhak Council (IMPC)

Second Party: Partnered institute expressed interest for the setup of Center of Excellence

RESPONSIBILITIES OF FIRST PARTY: IMPC

- 1. Setup of Center of Excellence:** The First Party shall purchase and set up the required equipment within the Center of Excellence at its own cost, including building upgrades, tools, and machinery to begin training programs.
- 2. Supervision and Operation:** The First Party shall supervise and do complete handholding of the operations and guidance for carrying out the operations to the second party.
- 3. Future Investment Prospectus:** Further investment, up to a minimum of 15 Lakhs will be done based on the performance of the institute in First Phase. Please refer to **ANNEXURE B** to know all milestones decided.
- 4. Branding and Promotion:** The First Party shall undertake branding and promotional activities for COE.
- 5. Faculty Training:** The first party shall organize multiple Training of Trainer (ToT) programs to enhance the skills of the existing faculty of the institute.
- 6. Operational Cost:** The First Party shall be responsible for the following: ToT fees, pre-visit, location sign-off fees, CAAF submission fees, physical inspections, monitoring fees, job role accreditation fees, remuneration for one center manager & one language trainer, and center branding.
- 7. Placement Assistance:** The first party will facilitate assistance for both domestic and international placements through its network and global partners.

RESPONSIBILITIES OF SECOND PARTY: PARTNERED INSTITUTE



1. Infrastructure allotment: The Second Party shall provide the necessary infrastructure as outlined below:

- A spacious 500 sqft open area designated as a Hawan Kund.
- A 5060 square-foot carpet area equipped with classrooms and basic amenities like Chairs, Desks, Fans, etc.

2. Operational Cost: The Second Party shall be responsible for covering the salary and remuneration of the faculty members selected to conduct the training sessions, Additionally, the Second Party will bear expenses related to building rent (if applicable), internet bills, electricity charges, and building maintenance.

REVENUE SHARE:

The revenue generated from COE shall be split 50:50 ratio between partnered institute and International Mandir Prabhandhak Council.
