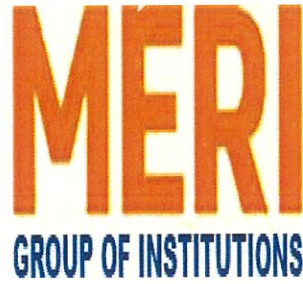

1. Parties

The parties to this Memorandum of Understanding (MOU) are:

Management Education & Research Institute - Group of Institutions, herein referred as MERI and Central Sanskrit University, New Delhi.

2. Purpose

2.1. The broad objectives of this MOU are to promote educational and scholarly exchange, collaboration and technological services exchange between the parties involved as educational partners.

2.2 The purpose of this MOU is to outline an academic and management framework between the two parties, designed to promote internationalization at both institutions.

3. Areas of Cooperation

3.1 Upon the mutual consent of both the parties, subject to the availability of funds, collaboration may be carried out in, but not necessarily limited to, the following areas:

- Exchange of materials in education and research, publications and academic information.
- Collaborative research and publication
- Joint organization of conferences, seminars or other academic meetings.
- Organization of exchange programs for students and faculty.
- Joint development and delivery of courses and programs.
- Joint fund raising activities for scholarships and grants.
- Joint scientific guidance of doctoral students.
- Recognition of academic courses in compliance with the internal regulations of two Parties and issuance of a double degree diploma.
- Support for massive program of online / E-learning / MOOCs / online books.

4. Implementation Mechanism of MoU

4.1 Each party to the MoU, will appoint one person to act as a Joint Manager/Nodal Officer in the execution of this MoU.



5. Duration of the MoU

5.1 This MoU will be effective upon signature by each authorized representative of both parties for a period of Five years, at which time it will be reviewed for possible renewal for another five-year period.


5.2 Either party may, with one month's written notice, terminate the MoU in advance of its normal expiration or request the renegotiation of its conditions. Under such circumstances, staff or students shall be allowed to complete the activity under the old conditions that have commenced before such notice is given by either party.

6. Nature of the MoU


6.1 This MoU is an expression of both parties of their general intent and is not legally binding for both the parties and does not impose any legal obligations whatsoever on either party. However, activities to be taken up, involving physical and financial aspects are decided by mutual consent.


6.2 Each party will keep a copy of this MoU.
