1. Interview of candidates shall be conducted through online mode only.
2. The Competent Authority, CSU, Delhi has decided that in case of receipt of applications in large number, the ratio of requirement of Guest Faculty vis a vis number of candidates to be called for interview shall be 1:5.
3. Accordingly, the required number of candidates will be called for interview as per merit drawn on scrutiny of applications. Any details/information not mentioned in the application form by the applicant will result his/her candidature as invalid. Information provided in the application form and attachments thereto, will not automatically entail for engagement as Guest Faculty. The selected candidates will be engaged after prior scrutiny of original certificates to be provided by the candidates. If any candidate selected for engagement fails to produce the originals at the time of verification of documents, the offer of engagement if issued, will be cancelled and the requirement will be fulfilled by engaging next applicant in the panel.
4. The applicants are advised to check the e-mail for the link, which will be provided one day before the scheduled interview given above. They are also required to ensure to keep themselves available online through desktop/laptop with good quality internet/webcam/audio (input/output) facilities and appear for interview in a pleasant environment maintaining decorum.
5. Applicants are also advised to adhere to the general information and terms & conditions given in earlier Notification dated 15.03.2022 issued in this regard.
