Subject: Identify and eliminate all obsolete or redundant laws with which Department of Higher Education is administratively concerned – Ref. received from Law Commission of India -reg.

The undersigned is directed to refer the Office Memorandum of even number dated 17-04-2025 of Govt. of India, Ministry of Education (Administrative Reforms Section) and subsequent reminder-I & II dated 01-05-2025 & 04-07-2025 respectively, forwarding therewith a D.O. letter No. 6(3)/311/2017-LC(LS) dated 11-04-2025 received from Law Commission of India addressed to Secretary, Higher Education, Govt. of India.

Vide said D.O. letter dated 11-04-2025, the Law Commission of India inter-alia provides that the Law Commission is initiated the study to identify and eliminate all obsolete or redundant Laws that no longer have any impending purpose, in order to streamline the legal framework and enhance operational efficiency.

The terms of reference set out by the Govt. of India for the Twenty -Third Law Commission is 'Review/repeal of obsolete laws' that is-

- (i) Identify laws, which are no longer needed or relevant and can be immediately repealed.
- (ii) Creating a Standard Operating Procedure for periodic review of existing laws inter-alia for the undertaking of simplification of language and processes.
- (iii) Identify laws which are not in harmony with the economic needs and requirements of the times and requirements.
- (iv) Identify laws which otherwise require changes or amendments and to make suggestions for their amendment.
- (v) Consider in a wider perspective the suggestions for revision/amendment in laws given by Expert Groups in various Ministries/Departments with a view to coordinating and harmonizing them.
- (vi) Consider references made to it by Ministries/Departments through the Department of Legal Affairs, Ministry of Law and Justice in respect of legislations having bearing on the working of more than one Ministry/Department.
- (vii) Suggest suitable measures for quick redressal of citizens in the field of law.

The Ministry of Education, Govt. of India (AR Section) has requested to all the Bureau Heads of Higher Education to identify 'obsolete or redundant laws' with which Department of Higher Education is administratively concerned and send the list of same to AR section for onward submission to Law Commission.

In view of above, it is therefore, requested to all the Sectional Heads at Headquarters Office of CSU/all Director of the Campuses of CSU/Principal/Director of ASMs/ASSs to furnish the requisite 'Review/repeal of obsolete laws' on the above mentioned (i) to (vii) points to the Legal Cell latest by 14th August, 2025 at E-mail: <a href="mailto:legal@csu.co.in">legal@csu.co.in</a> so that list of same may be sent to AR Section of Ministry of Education, Govt. of India for onward submission to Law Commission of India.
