
Consequent upon his appointment as Vice-Chancellor, Uttarakhand Sanskrit University, Haridwar with reference to letter no. 27702/जी.एस. (शिक्षा)/C5-8(4)/2018 dated 14<sup>th</sup> January, 2026 of Governor's Secretariat, Uttarakhand, Dehradun, Prof. Ramakant Pandey, Senior Professor (Sahitya) of this University, currently functioning as Director at Central Sanskrit University, Jaipur Campus, Jaipur, is hereby permitted to take up the said appointment of Vice Chancellor at Uttarakhand Sanskrit University, Haridwar on deputation basis for a period of 03 years or till further orders, w.e.f. 16.01.2026. The deputation of Prof. Ramakant Pandey will be subject to terms and conditions laid down by the Govt. of India in force and subsequent modifications issued thereon from time to time, and also in anticipation of ratification by the Executive Council of the Central Sanskrit University, Delhi. The appointment will be further subject to the provisions contained in the Central Sanskrit Universities Act, 2020 and its Statutes, Ordinances, Rules and Regulations as amended from time to time and resolutions of the Executive Council of the University.

Prof. Ramakant Pandey shall stand relieved of his duties at Central Sanskrit University, Delhi on 15.01.2026 (A/N) and he will be entitled for his salary upto and including 15.01.2026 in this University. Prof. Ramakant Pandey will hand over the charge of Director of CSU, Jaipur Campus, Jaipur, to Prof. Lokmanya Mishra, Senior most Professor in the Campus.

Uttarakhand Sanskrit University, Haridwar will have to remit pro-rata Leave Salary and Pension Contribution in respect of Prof. Ramakant Pandey to this University, on monthly basis, as per rules.

Prof. Ramakant Pandey will submit intimation about his joining as Vice-Chancellor at Uttarakhand Sanskrit University, Haridwar through their Registrar to this University within 15 days of his joining, for record.
